ASSIGNMENT OF SPACE

Exhibit space and sponsorships are assigned on a first come first serve basis based on partner level, date of reservation, and separation of competitive companies. The NSDDS will make every effort to accommodate exhibit preferences. NSDDS reserves the right to assign all spaces, rearrange the floor plan, and re-locate exhibits as needed.
